Small Matters


If elected I will be advocating that there are recyclable poo bags on hand at Derbyhaven as I know that residents have to deal with the effects of dog walkers from all over the island that walk their dogs there but are not properly prepared or take responsibility for their pets.

A cycleway has been approved by both Malew and Castletown commissioners linking Ballasalla with Castletown. However, as yet no progress has been made on actually creating this cycle route, to the frustration of both cyclist and motorist. This is something that I will be pursuing.

A third example is a linking country path that follows the stream from Ballasalla to Castletown. This has not been maintained prohibiting active travel and a chance to enjoy a walk along the stream. There are many issues such as these and I consider them of noticeable importance alongside the bigger issues.

The Big Issues

Malew will be considering in the coming months the Ballasalla by-pass, the completion of the Clagh Vane housing estate and the 'Ronaldsway gateway'. The Ballasalla by-pass is an understandable necessity for anyone living on the main road through Ballasalla. I can fully appreciate that living on this road with



Clagh Vane housing estate is in its final phase. I would continue to ensure that it is future proofed and that proper recycling facilities, cycle lanes, and an inspiring environment are maintained. As equality is a fundamental principle of the Green party we need to ensure that the people most in need share in the benefits of this new estate.

Ronaldsway gateway presents Malew with an ideal opportunity to reduce the cost of business undertaken and create an exciting business park that supplements each other. I would be encouraging businesses to look at the current energy savings scheme offered by the government where solar thermals can be fitted on interest-free loans.
